Ordinance

1. This Ordinance may be cited as the Postgraduate Institute of Medicine (Amendment) Ordinance, No. 2 of 1990, and shall come into force on 28th December, 1990.

2. Paragraph 10 of the Postgraduate Institute of Medicine Ordinance No. 1 of 1980 published in *Gazette Extraordinary* No. 83/7 of April 10, 1980, as amended by *Gazette Extraordinary* No. 379/9 of December 10, 1985, is hereby further amended as follows:—

(1) by the substitution for sub-paragraph (1) thereof, of the following sub-paragraph:—

(1) the following *ex officio* members, namely—

- (a) the Director;
- (b) the Secretary to the Ministry of the Minister in charge of the subject of Higher Education or the nominee of such Secretary;
- (c) the Secretary to the Ministry of the Minister in charge of the subject of Health or the nominee of such Secretary;
- (d) the Secretary to the Ministry of the Minister in charge of the subject of Teaching Hospitals or the nominee of such Secretary;
- (e) the Secretary to the Ministry of the Minister in charge of the subject of Finance or the nominee of such Secretary;
- (f) the Chairman of the University Grants Commission;
- (g) the Director-General of Health Services;
- (h) the Director of Teaching Hospitals;
- (i) Deputy Director-General of Health Services in charge of the subject of Medical Services;
- (j) the Dean of the Faculty of Medicine of the University of Colombo, Sri Lanka;
- (k) the Dean of the Faculty of Medicine of the University of Peradeniya, Sri Lanka;
- (l) the Dean of the Faculty of Medicine of the University of Jaffna, Sri Lanka;
- (m) the Dean of the Faculty of Medicine of the University of Ruhuna, Sri Lanka; and
- (n) the Dean of the Faculty of Dental Sciences of the University of Peradeniya, Sri Lanka.

(2) by the substitution for the proviso to sub-paragraph 2(e) thereof, of the following proviso:—

“provided that, at least five members so appointed shall be from among the members of the medical profession, one of whom shall be the immediate past Director of the Institute.”
