THE UNIVERSITIES ACT, No. 16 OF 1978

ORDINANCE made by the University Grants Commission under Section 140, read with Section 18 of the Universities Act, No. 16 of 1978.

Ordinance

1. This Ordinance may be cited as the Postgraduate Institute of Medicine (Amendment) Ordinance and shall come into operation on the date of its publication in the *Gazette*.

2. The Postgraduate Institute of Medicine Ordinance, No. 01 of 1980 published in the *Gazette Extraordinary* No. 83/7 of 10th April, 1980 as last amended by the Postgraduate Institute of Medicine (Amendment) Ordinance and published in *Gazette Extraordinary* No. 755/7 of 15th February 1993, is further amended as follows:

(1) In paragraph 13 thereof, by the addition at the end of sub-paragraph (p) of that paragraph of the following sub-paragraph:-
“(q) Medical Administration.”

(2) In paragraph 14 thereof -

(a) by the addition at the end of clause (e) of sub-paragraph (1) of that paragraph of the following new clause:

“(f) where the Faculty Boards of each of the Faculties of Medicine and Dental Science of the Universities, established under the Act are unable to elect a member under clauses (d) and (e) of this sub-paragraph, such Faculty Boards may elect a member from among the part time teachers of the Hospital Consultant staff.”

(b) by the insertion immediately after clause (d) of sub-paragraph (2) thereof, of the following new clause:

“(dd) where the Faculty Boards of each of the Faculties of Medicine and Dental Science of the Universities, established under the Act are unable to elect a member under clauses (c) and (d) of this sub-paragraph, such Faculty Boards may elect a member from among the part time teachers of the Hospital Consultant staff.”

(3) In paragraph 25 thereof by the substitution in the definition of “Speciality in Medicine” for the words “Dental Surgery and Health Science” of the words “Dental Surgery, Medical Administration and Health Science.”
