THE UNIVERSITY ACT, No. 16 OF 1978

Ordinance

1. This Ordinance may be cited as the Postgraduate Institute of Medicine (Amendment) Ordinance, No. 4 of 2000 and shall come into force upon publication in the *Gazette*.

2. The Postgraduate Institute of Medicine Ordinance No. 1 of 1980 published in *Gazette Extraordinary* No. 83/7 of April 10, 1980 as last amended by the Postgraduate Institute of Medicine (Amendment) Ordinance, No. 1 of 2000 published in *Gazette Extraordinary* No. 1133/9 of May 23, 2000 is hereby further amended as follows :

(1) In paragraph 14 thereof -

- (i) by the substitution in item (d) (i), of sub-paragraph (1) of that paragraph for the words "except specialites of Community Medicine; Family Medicine and General Practice" of the words "except specialities of Community Medicine, Family Medicine and General Practice -";
- (ii) by the repeal of item (e) (1) of sub-paragraph (1) of that paragraph, and the substitution of the following item therefor:
“(e) two members from the relevant professional body, except in the specialities of Family Medicine and General Practice, of whom -”;
- (iii) by the substitution in item (c) (iii) of sub-paragraph (2) of that paragraph, for the words "training centre, and the Cancer Institute, Maharagama" of the words "training centre, the Cancer Institute, Maharagama";
- (iv) by the insertion immediately after item (c) (iv) of sub-paragraph (2) of that paragraph of the following item :-
“(d) two members from the relevant professional body.”;
- (v) by the substitution in sub-paragraph (3) of that paragraph, for the words "after Board Certification of Eligibility" of the words "after Board Certification or Eligibility";
- (vi) by the repeal of the proviso to sub-paragraph (3) of that paragraph and the substitution of the following proviso therefor:
“ Provided, however, that the representatives from the training centres referred to in sub-paragraph (1) (d) and paragraph (2)(c), shall be selected by the trainers of the Ministry of Health of the relevant speciality, in the training centres, as the case may be. The Director-General of Health Services or the Director of the Sri Jayawardenepura Hospital shall submit names of such persons who have been selected to the Director.”.

(vii) by the repeal of item (c) (i) of sub-paragraph (3A) of that paragraph, and the substitution of the following item therefor :

“(i) three members shall be from the Main Training Centre, Dental Institute of Colombo;”;

(2) in paragraph 25 thereof, by the substitution in the definition of "Speciality of Medicine" for the words "Radiotherapy and Oncology" of the words "Clinical Oncology".
